Jonelle and Bryce Jordan Scholarship in the Arts Application

The Jonelle and Bryce Jordan Scholarship in the Arts directly helps students who are enrolled in the arts at the Harry W. Bass Jr. School of Arts, Humanities, and Technology at the University of Texas at Dallas. Recipients will meet the following criteria: undergraduate or graduate student enrolled in at least one course in the Visual and Performing Arts area or in Creative Writing. New and transfer students must have been accepted by The University of Texas at Dallas prior to applying for a Jonelle and Bryce Jordan Scholarship in the Arts. Continuing students must be in good academic standing and must enroll full-time during the scholarship period. Renewals are not automatic, but students may reapply for subsequent scholarships for a total scholarship period of up to four years. Award recipients are selected by the AHT Scholarship Selection Committee. Up to ten awards of \$2,000 each are available during the 2024-2025 academic year.

- 1. This application form, completed and signed. (UTD email or manually signed copy)
- 2. Personal essay of 250-300 words.
- 3. Your current resume or CV that details your experience and achievements in the field and a sample of your work. (Samples may include: Performances and past training for dance, music, theater, including a short video of a performance. A writing sample of no more than 10 pages for creative writing. A short Powerpoint including 4-5 of your best works for art for visual art.)
